### RULES

#### Applicant must be:

1. Age 19-26 and may not enter if 26<sup>th</sup> birthday is prior to competition deadline.
2. Enrolled as a Music Major in a college or university affiliated with The Ohio Federation of Music Clubs.
3. Entrant may not receive a first place award in two consecutive years.
4. Applicant is a US citizen.

#### Award:

1. A \$1,000 award will be given to the collaborative pianist who demonstrates superior musicality and skills. The award will be determined by the adjudicators whose decision will be final. Unless high standards of performance are met, no winner will be declared.
2. There will be a \$200 honorarium for the soloist or ensemble who is a part of the winning group.

#### Audition Requirements:

1. Applicant is required to play two pieces or movements showing different styles.
2. Music should be a minimum of 15 minutes and a maximum of 20 minutes in duration.
3. Applicant must bring soloist/ensemble with whom he/she has been working with plus music for the judges. (No photocopies!)
4. Applicant will be judged on: cohesiveness and rapport of performers, balance, technique, rhythm, phrasing, quality of tone, style.

#### Repertoire:

1. Select from Classical vocal and instrumental repertoire.
